

RULES OF THE BEHAPOWIEC GYM CLUB

These regulations define the rights and obligations of Behapowiec Gym members.

The facility provides gym services.

1. Users of the club's services are required to purchase a single entry or a monthly pass at the reception.

monthly - in accordance with the valid price list. In order to receive the card, it is necessary to read the following regulations, signing the declaration form and paying the fee. If you lose the pass it becomes invalid.

The Club will not refund any money for a purchased the pass - unused training sessions do not constitute grounds for refunds or to extend the validity of the pass. Only on the basis of a medical certificate the pass can be extended for no more than 14 days.

3. The purchased the pass is personal and cannot be used by others. The pass is valid only up to the expiry date stated on the ski pass and cannot be rescheduled. The price of the pass does not include insurance. Provision of the pass to other people is a breach of these Regulations and will result in expulsion from the Club without the right to claim a refund of fees paid.

4. Upon arrival at the Club, it is compulsory to present the Club pass and leave it at the reception desk, then leave it at the reception desk in order to receive your locker key. When you have finished exercising, you should return the key and collect the pass. In the event of a broken or lost locker key, a fee of PLN 39 will be charged.

5. Each class participant should lock his/her clothes in the locker for the duration of training. The Club is not responsible for valuable items and clothes that are left in the locker room, in lockers or on the premises of the Club.

6. Exercisers are required to bring a sports outfit and bring their own towel to lay on gym equipment.

7. Passes are issued for a fixed period including Saturdays, Sundays and holidays. The club also reserves the right that it may be closed on holidays and Sundays.

8. In the Club it is compulsory to wear changeable footwear - different from the footwear in which you came to the Gym - with clean soles,. During sports classes and gym exercises, the following rules apply sports footwear designed for this type of activity. The following are not allowed: flip-flops, ballet shoes, barefoot exercise barefoot shoes other than sports shoes are not allowed, unless advised otherwise by the instructor/trainer.

9. Smoking and alcohol consumption are strictly prohibited in the Club area. This also applies to doping and stimulants - steroids, drugs and other intoxicants. It is forbidden to bring any food products into the gym area. Chewing gum is also strictly prohibited during exercise.

10. Use of the halls, sports and recreation equipment and sanitary facilities should be in accordance with their intended use. Participants are obliged to maintain tidiness in changing rooms, showers, toilets and to respect the equipment in the toilets.

11. In the training room, all instructions and remarks of instructors must be obeyed and the Club rules must be observed.

It is essential to use protective mats (towels) when exercising with free weights. It is not allowed to shout, throw equipment directly onto the floor or behave indecently. People in the Behapowiec Gym

are obliged to show tolerance and understanding towards each other. It is forbidden to use vulgar language, aggressive behaviour or being aggressive towards another person.

12. The customer will be held legally or financially responsible for any devastation of Club property and any deliberate action to the detriment of the Club.

13. Exclusion from the Club and revocation of membership occurs upon violation of public order or the provisions of these rules. The customer will be notified orally by an employee of the Club. In case of banning and exclusion from the Club, there will be no refund of the value of the unused pass and other charges incurred.

14. Behapowiec Gym reserves the right to refuse admission to the Club without giving any reason.

15. People under the age of 18 may use the services provided by the Club only with the written Consent from parents or legal guardians. The minimum age for gym users is 14 years.

16. People exercising in the club declare that they have no health contraindications to exercise and participate in activities on the premises. Members with health problems should consult a physician before starting to exercise. Members should consult a sports doctor and provide a medical certificate.

17. In case of sickness, injuries and any serious health problems and pregnancy, the instructor or staff member must be informed.

18. Only a Behapowiec Gym employee is authorised to control the air conditioning etc.

19. Behapowiec Gym reserves the right to change prices and opening hours.

20. Behapowiec Gym is not responsible for accidents resulting from non-compliance with the programme and instructions recommended by the trainer or staff.

21. Each client is required to read and comply with these rules and other regulations in force on the premises of the Club.

22. Staff members supervise the observance of these rules. All complaints and requests should be reported directly to the Club reception desk.

23. The Club reserves the right to conduct personal training sessions only by Club employees.

The processing of personal data will take place in accordance with Article 6 act 1b and f of the

General Data Protection Regulation in order to carry out the provision of the booking. The legitimate interest of the Data Controller, in order to secure or assert possible claims, is to fulfil contractual obligations.

Access to personal data will be granted to authorised employees to the necessary extent, Recipients of the data will be institutions authorised by law.

Personal data will be stored for the duration of the service, and thereafter for the period necessary for:

- post-sale customer service,
- fulfilment of the Administrator's legal obligations,
- the investigation of possible claims by and against the Data Controller.

You have the right to:

- access to the content of your data, i.e. the right to obtain confirmation as to whether the Administrator is processing your data and information concerning such processing,
- rectification of your data if the data processed by the Administrator are incorrect or incomplete,
- to request the erasure of his/her data,
- request for restriction or transfer of the processing of your data,
- to lodge an objection, to lodge a complaint with a supervisory authority regarding the processing of your data.
- Your data will not be transferred to a third country / international organisation.
- The provision of your personal data is voluntary, but necessary in order to make a declaration - inclusion in the customer database of the gym. You are obliged to provide this data and the consequences of failing to do so are as follows

- The Administrator makes every effort to ensure all technical and organisational measures protection of personal data against their accidental or wilful destruction, accidental loss, alteration, unauthorised disclosure, use or access, in accordance with all applicable regulations.
